Details of 5-Deaths as follows:

1. A '49' Yrs old male, from Old Market, Tawang district expired on 14.05.2021 (08.40 AM) at DCHC, Tawang. He was suffering from Hypertension with Covid-19 Positive tested through True Nat at DCHC, Tawang on 06.05.21 and expired due to Acute Respiratory Distress Syndrome. The patient was vaccinated 1st done on 24.04.2021. The body was handed over to the relatives as per COVID-19 protocol.
2. A '6' Yrs old male child from Chimpur, near oil depot admitted with shortness breath on 14.05.21(2.40 PM) in RKM Hospital isolation ward in critical condition. His urgent CT Thorax is suggestive of severe COVID Pneumonia and expired due to Acute Respiratory Distress Syndrome on 14.05.21(4.30 PM). The body was handed over to the relatives as per COVID-19 protocol.
3. A '65' Yrs old male, referred from Roing expired on 13.05.2021 (06.50 AM) at AMCH, Dibrugarh. He was suffering from Acute Kidney Injury & Dyselectrolytemia. Patient tested Covid-19 Positive through RAT at DH-Roing on (20.04.2021), same day patient was referred to AMCH, Dibrugarh, Assam and expired due to cardio respiratory failure. The vaccination status of patient is Nil.
4. A 52 Yrs Male, of Basar, Leparada district who was referred from DH-Roing expired on 14.05.21 (9.15 AM) at DCH-Pasighat. Patient tested Covid-19 Positive through RAT at DH-Roing on (05.05.2021) and expired due to COVID Pneumonia. The patient was vaccinated 1st done on 02.05.21. The body was handed over to the relatives as per COVID-19 protocol.
5. A '45' Yrs female, from Lekhi village who was suffering COVID Pneumonia and Diabetes Mellitus Type-II and admitted on 1.05.21, expired at 06.50 PM on 14.05.21 at DCH-Chimpur. Further, relative of the deceased has decided to hand over the dead body to the administrative for final disposal.
